### 3 CSR 10-9.570 HOUND RUNNING AREA: PRIVILEGES, REQUIREMENTS.

New areas approved after March 1, 2005 must be at least forty (40) acres in size.

The holder of a Hound Running Area Operator and Dealer Permit may obtain live foxes and coyotes from a holder of a valid trapping permit as prescribed in 3 CSR 10-8.515(7). Permittees may also purchase foxes and coyotes from a holder of a Class I Wildlife Breeder Permit or a holder of a Hound Running Area Operator and Dealer Permit. Foxes and coyotes may be held in temporary confinement facilities on the hound running area or another location specified on the permit. These foxes and coyotes may only be released into a permitted hound running area and must be individually marked with ear tags provided by the department for which the permittee shall pay fifty cents (50¢) per tag. These animals may not be given away, released to the wild or exported, except with written authorization of the director.
