Nonresident fur dealers shall conduct business **only** at the locations in Missouri specified on the permit, with resident fur dealers at their business location and at established fur auction sites.

If you are a Non Resident Fur Dealer and plan to purchase fur in Missouri at a location other than either established fur auctions or the location of licensed Missouri fur dealers, list the business name and complete address of the location on the back.

Missouri's Sunshine Law requires that permit buyers' names and addresses are public records unless you specifically request that your information be closed.
