

Area Highlights

The 1,453 -acre Rockwoods Range was acquired by the Conservation Department in 1943, thanks in large part to A.P. Greensfelder, who donated the land to preserve it in public ownership. Mr. Greensfelder was one of the first four people appointed to serve on the Conservation Commission. A memorial on the area designates where a uniquely designed round house that Greensfelder built as a summer cottage once stood. The 2012 donation of 55 additional acres by Patricia Muckerman in memory of LaVerne Rogan brings the area to its current acreage of 1,453 acres. The area is mostly forested, but springs, limestone rock outcrops and sinkholes are common on the area. The area supports good populations of deer, turkey, squirrels, raccoons, foxes and songbirds. This area has been designated by Audubon Missouri as an Important Bird Area (IBA). IBAs are sites that have been identified by Audubon as those that are the most crucial for bird populations, due to their abundance and/or diversity of birds present.

Rockwoods Range is closed from one-half hour after sunset to sunrise daily.

- Horseback riding and bicycles are permitted on multi-use trails only. Groups of more than 10 need a special-use permit.
- Hiking permitted on interior roads and trails.
- Dogs must be leashed. Dog training allowed by special-use permit only.
- Camping and fires are prohibited.
- Caving is prohibited.
- Motor vehicles are allowed on public roadways and in parking areas.
- Nuts, berries, fruits, mushrooms and wild greens may be taken for personal use. Digging, cutting or removing other vegetation is prohibited.
- Collecting wildlife is prohibited.

- Hunting is prohibited except for managed hunts only. Hunters must apply through the managed hunt drawing system. Application information is available at most Conservation Department offices.
- Fishing and trapping are prohibited.
- Target shooting is prohibited.

Round House Loop Trail – multi-use	3.0 miles
Fox Creek Spur Trail – multi-use	0.6 mile
Fox Run Trail – multi-use	3.5 miles
Green Rock Trail – hiking only	2.9 miles

of the 14.5-mile trail wind through the area

To reach Rockwoods Range, exit I-44 at Allenton-Six Flags Road in Eureka. Go north to first stoplight and turn left on Fox Creek Road for 2 miles to parking lot.

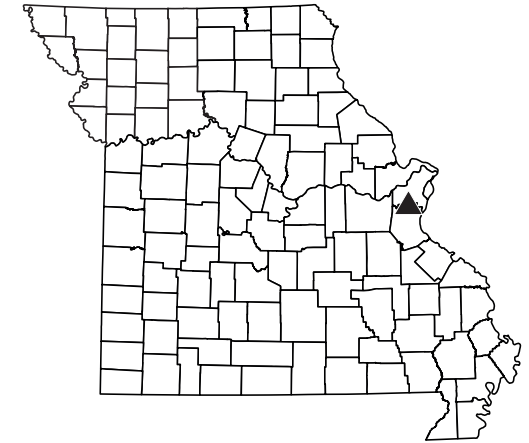
