## **Recreational Opportunities**

Hunting – Fishing – Camping – Hiking Nature study and wildlife viewing -Outdoor Photography

Conservation Areas are closed from 10 p.m. to 4 a.m. except for authorized camping, fishing and hunting, and dog training activities.

- No littering.
- No fireworks.
- No open fires.

 Dogs must be leashed when not used for training or hunting.

 Nuts, berries, fruits, mushrooms and wild greens may be taken for personal use. Cutting or removing other vegetation is prohibited.

 Primitive camping is permitted in spots designated on the area map. Campers are limited to 14 consecutive days'in a 30-day period. Groups of more than 10 need a special-use permit.Motor vehicles are allowed on public

roadways and in parking areas.

 Horséback riding is not allowed on the area.

Target shooting is not allowed.

Świmming, scuba diving, water skiing, sailboarding, skateboarding, caving and rappelling are not allowed.

## Fishing and Boating

Fishing and frogging are permitted under statewide regulations with the following exceptions:

 On lakes and ponds fish may be taken only with pole and line and not more than three (3) poles may be used by one (1) person at any time.
In lakes and ponds, daily limits are 4

catfish in the aggregate (channel, blue, and flathead); 6 black bass, 30 crappie; and all other fish, statewide limits, but not to exceed 20 in the aggregate.

 In lakes and ponds, black bass more than 12" but less than 15" must be returned to the water unharmed immediately after being caught.

 Seining or trapping live bait, including tadpoles, is prohibited.

 Salvage seining of non-game fish for personal use is permitted only with written authorization.

# Hunting and Trapping Hunting is allowed under statewide

regulations with the following exceptions:

• Deer and turkey regulations are subject to annual changes. Please refer to the Spring Turkey or Fall Deer and Turkey Hunting pamphlets for current regulations.

 Portable tree stands may be used between Sept. 1 and Jan. 31. Stands must be identified with the name and address, or conservation number of the user. Screw-in steps or other materials that would damage the tree are prohibited.

 Decoys and portable blinds are permitted but must be removed from the area daily. Blinds may be constructed on-site, but only from willows and nonwoody vegetation.

 Furbearer trapping is permitted by special-use permit.

From Stockton, take Route J north 6 miles, then County Road 752 west 0.5 mile, County Road 1701 north 0.25 mile, then County Road 724 west 0.25 mile.


