RECREATIONAL OPPORTUNITIES

Bird watching — Bicycling — Fishing Hiking — Hunting

Conservation Areas are closed from 10 p.m. to 4 a.m. except for authorized camping, fishing and hunting activities.

- Groups of 10 or more need a special use permit.
- Guiding for pay is prohibited on department areas.
- Use of fireworks is prohibited.
- Horses and horseback riding are prohibited.

• Bicycles allowed on designated service roads year-round. Service roads can be located at *https://mdc.mo.gov/discover-nature/places*.

- Hiking is permitted on interior roads and trails.
- Walk-in/backpack camping is allowed. Camping is allowed along interior roads and/or parking lots. No amenities are provided. Seasonal closures and restrictions may apply.

• Vehicles are restricted to public roadways and parking lots unless otherwise allowed by area regulations.

- Nuts, berries, fruits, mushrooms and wild greens may be taken for personal use. Cutting or removing other vegetation is prohibited. Digging of roots is prohibited on all Conservation areas.
- Dogs must be leashed when not used for training or hunting.

Fishing and Boating

Fishing and frogging are allowed under statewide regulations with the following exceptions on impoundments:

- Fish may be taken only by pole and line and not more than 3 poles may be used by any person.
- Seining or trapping live bait, including tadpoles, is prohibited.
- Salvage seining of non-game fish for personal use is permitted only with written authorization.
- Boats may be used only for fishing and wildlife activities and may not be left unattended overnight.

• Daily limits are catfish in the aggregate (channel catfish, blue catfish, flathead catfish), four (4); black bass, six (6); crappie, thirty (30); and all other fish, statewide limits, but not to exceed twenty (20) in the aggregate.

• All black bass more than 12 inches but less than 15 inches must be returned to the water unharmed immediately after being caught.

• Only electic motors are permitted. Use of houseboats and personal watercraft is prohibited.

Hunting and Trapping

Hunting is allowed under statewide regulations with the following exceptions:

• Deer hunting is permitted under statewide seasons and limits except only muzzleloader and archery methods may be used.

Single projectile firearms prohibited except small game may be hunted with .22 rimfire or smaller.
Portable tree stands may be used only between Sept. 1 and Jan. 31. Stands must be identified with the name and address, or conservation number, of the user. Screw-in steps or other materials that would damage the tee are prohibited.

• Furbearer trapping is permitted by special use permit.

• Decoys and blinds must be disassembled and removed daily.


