

## Recreational Opportunities

Bird Watching – Fishing - Hiking – Hunting -  
Outdoor Photography

Conservation areas are closed from 10 p.m. to 4 a.m. except for authorized camping, fishing and hunting activities.

- No littering.
- No fireworks.
- No open fires. Pitted fires only in designated areas.
- No free-running pets. Dogs must be leashed or confined when not being trained or used for hunting.
- Destroying, cutting or removing vegetation is prohibited. Nuts, berries, fruits, mushrooms and wild greens may be taken for personal consumption only.
- Motor vehicles are restricted to roadways and parking areas.
- Bicycles allowed on designated service roads year-round. Service roads can be located at <https://mdc.mo.gov/discover-nature/places>
- Camping is permitted only in designated areas and is limited to 14 consecutive days in a 30-day period. All personal property must be removed from the area at the end of the 14-day period.
- Groups of 10 or more people must obtain a special-use permit.
- No target shooting allowed.

## Fishing and Boating

Fishing is permitted under statewide regulations. The following special regulations also apply:

- On streams, fishing is permitted under statewide regulations. Other restrictions may apply to specific ponds, lakes and stream segments.
- On impounded waters, daily limits are 6 black bass, 4 catfish in the aggregate (channel, blue and flathead) and 30 crappie. All other fish taken may not exceed a combined total of 20.
- All black bass between 12 and 15 inches in total length must be returned to the water unharmed immediately after being caught. Pole and line methods only.
- Bullfrogs and green frogs may be taken during the statewide season only by hand, handnet, atlatl, gig, bow, snagging, snaring, grabbing, pole and line, a

twenty-two (.22) caliber or smaller rimfire rifle or pistol, pellet gun, or crossbow, only on waters and within dates and hours those waters are open to fishing.

- Seining or trapping live bait, including tadpoles, is prohibited on all lakes and ponds.
- Electric motors only are allowed.

## Hunting and Trapping:

Area is open to hunting under statewide regulations. The following special regulations also apply.

- Deer hunting is permitted under statewide seasons and limits except: archery antlerless and firearms antlerless permits may not be used. Deer hunting is permitted on the area under the following regulations:
  - Deer and turkey regulations are subject to annual changes. Refer to Spring Turkey or Fall Deer and Turkey booklets for current regulations.
  - Only portable tree stands are allowed and only from Sept. 1 through Jan. 31. Unattended stands must be plainly labeled on a durable material with the full name and address, or Conservation Number, of the owner and be removed from the area before Feb 1. Use of nails, screw-in steps, and any material or method that would damage the tree is prohibited.
  - Trail and game cameras are prohibited.
  - Trapping of furbearers is permitted only as specifically authorized by special use permit.

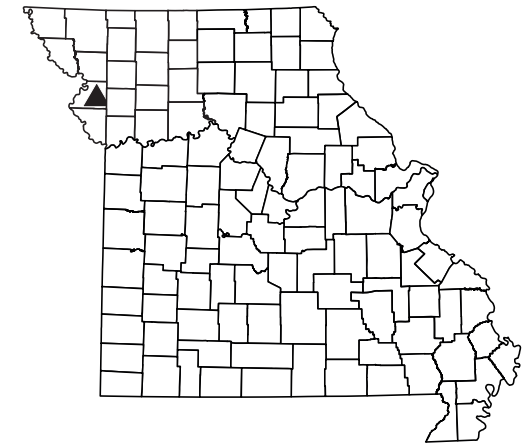
