

## Recreational Opportunities:

Bird Watching – Bicycling – Hiking –  
Wildlife Viewing

Conservation Area is closed from 10:00 pm  
to 4:00 am.

- No littering.
- No fireworks.
- No open fires, except in charcoal grills provided at the picnic shelters.
- No free-running pets; all pets must be leashed or confined. City ordinance requires pets to be leashed.
- Destroying, cutting or removing vegetation is prohibited. Nuts, berries, fruits, mushrooms and wild greens may be taken for personal consumption only.
- Motor vehicles are restricted to roadways and parking areas.
- Bicycles allowed on designated service roads year-round. Service roads can be located at <https://mdc.mo.gov/discover-nature/places>. Bicycles, skate boards and roller blades are allowed only on trails, operators must go slow and yield to pedestrians.
- Camping is not permitted
- Swimming, scuba diving, water skiing, ice skating, sailboarding, caving and rappelling are not allowed.

## Hunting, Fishing and Trapping:

- Area is closed to all hunting, fishing and trapping activities.
- Trail and game cameras are prohibited.
- More than 75 species of native and non-native trees were planted throughout the area in 1997 to display the different kinds of trees that are commonly planted in the urban landscapes across Missouri.

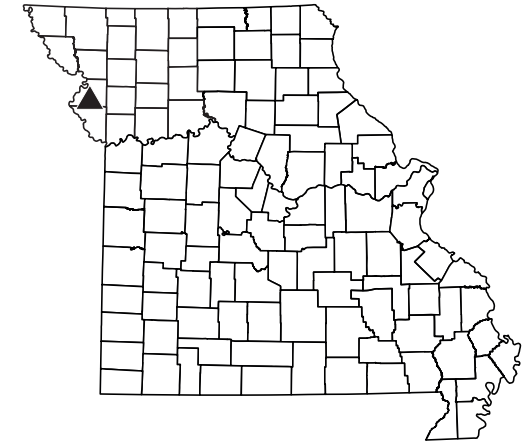
