About This Area

The Harter area is named after James R. Harter who donated the land to the Conservation Department in 1993. To preserve his land as a home for wildlife, Mr. Harter willed that it be developed as a Conservation Area as a gift to the people of Missouri.

Rules and Regulations

Conservation Areas are closed from 10 p.m. to 4 a.m. except for authorized fishing and hunting activities.

- No littering.
- No fireworks.
- No open fires.
- No free-running pets. Dogs must be leashed or confined when not being trained or used for hunting. The training of hunting dogs is permitted only by holders of a Missouri small game hunting permit.
- Destroying, cutting or removing vegetation is prohibited. Nuts, berries, fruits, edible wild greens and mushrooms may be taken only for personal consumption.
- Vehicles and bicycles are restricted to roadways and parking areas. No vehicles or bicycles are allowed off-road.
- Bicycles allowed on designated service roads year-round. Service roads can be located at <https://mdc.mo.gov/discover-nature/places>.
- Horseback riding is permitted only on roads open to vehicles.
- No camping permitted.
- No target shooting allowed.
- Swimming, scuba diving, water skiing, sailboarding, skateboarding, caving and rappelling are not allowed.
- Collecting plants, animals or artifacts, removing water and digging or otherwise disturbing the soil are prohibited.
- Trail and game cameras are prohibited.

Fishing and Boating

Fishing and frogging are allowed under statewide regulations with the following exceptions:

- Fishing is permitted in area streams under statewide regulations.
- In lakes, ponds and impoundments, fish may be taken only by pole and line and no more than three poles and lines may be used by any one person.
- Daily limits are six black bass and four catfish in the aggregate (channel, blue and flathead catfish) and 30 crap-

pie. All other fish fall under statewide limits, but the total number taken may not exceed 20.

- Black bass between 12 and 15 inches in total length must be returned to the water unharmed immediately after being caught.
- Bullfrogs and green frogs may be taken during the statewide season only by hand, handnet, atlatl, gig, bow, snagging, snaring, grabbing and pole and line.
- Firearms and crossbows may not be used to take bullfrogs and green frogs.
- Salvage seining of non-game fish for personal use is permitted only with written permission.
- Boats may be used for fishing and wildlife activities only and may not be stored or left unattended overnight.
- Electric motors only are allowed.

Hunting and Trapping

- Deer and turkey regulations are subject to annual changes. Refer to Spring Turkey or Fall Deer and Turkey booklets for current regulations.
- Deer hunting is permitted under statewide seasons and limits except: only archery methods may be used. The use of antlerless permits is not allowed.
- Only bucks that have at least four antler points on one side of their rack may be taken during the archery and firearms deer hunting seasons (except the youth portions).
- Only portable tree stands are allowed and only from September 1 through January 31 on areas where deer hunting is allowed, by special use permit, or except as otherwise authorized. Unattended stands must be plainly labeled on a durable material with the full name and address, or Conservation Number, of the owner and be removed from the area before February 1. Use of nails, screw-in steps, and any material or method that would damage the tree is prohibited.
- All other hunting and trapping is prohibited.

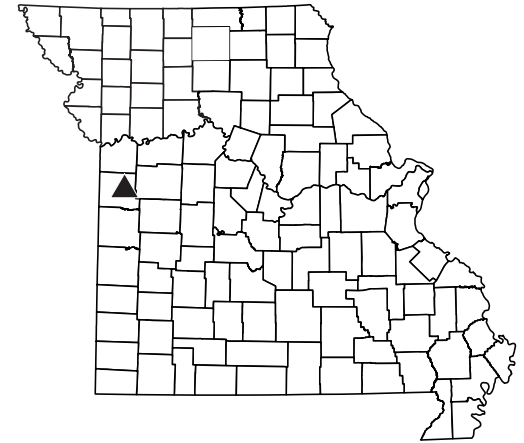
