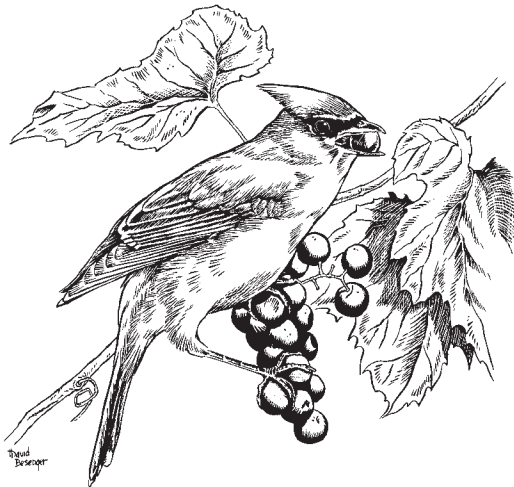


Recreational Opportunities

Bicycling – Bird Watching – Hiking – Hunting –
Outdoor Photography – Wildlife Viewing

Conservation Areas are open from 4:00 a.m. to 10:00 p.m.; hunting, fishing, trapping, camping, dog training, launching and landing boats allowed 24 hours a day on areas where these activities are permitted.

- Groups of more than 10 and some special activities may require a special use permit. Please visit our website for more information.
- Nuts, berries, fruits, edible wild greens, and mushrooms may be taken only for personal use.
- Digging roots is prohibited.
- Vehicles are only permitted on public roadways and in parking lots.
- No camping, except by permit.
- No open fires, except by permit.
- Pets and hunting dogs are permitted but must be on a leash or confined at all time. Dog training is prohibited on this area.
- Guiding for pay is prohibited.
- Use of fireworks are prohibited.
- Field trials prohibited.
- Target shooting is prohibited.



Hunting and Trapping

- Deer and turkey regulations are subject to annual changes. Please refer to the Spring Turkey or Fall Deer and Turkey Booklets for current regulations.
- Only portable stands are allowed from September 1 through January 31. Unattended stands must be plainly labeled on a durable material with the full name and address or Conservation number of the owner and be removed from the area by February 1st. Use of nails, screw-in steps, and any material or method that would damage the tree is prohibited.
- Trapping of furbearers allowed only with a special use permit. Visit our website for more information.
- Trail and game cameras are prohibited.

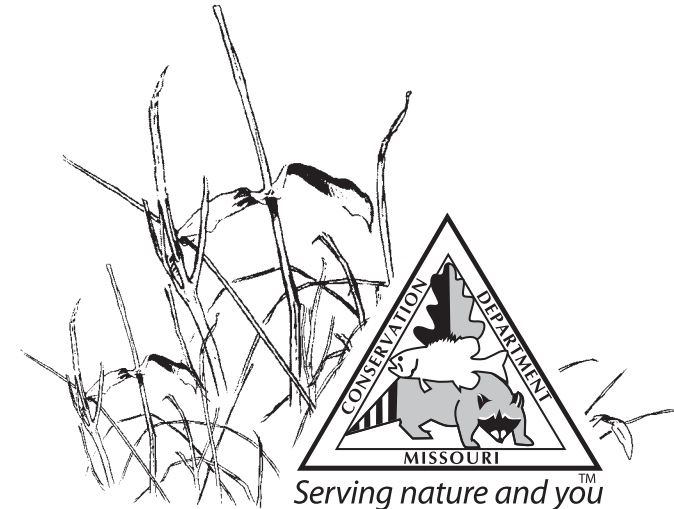
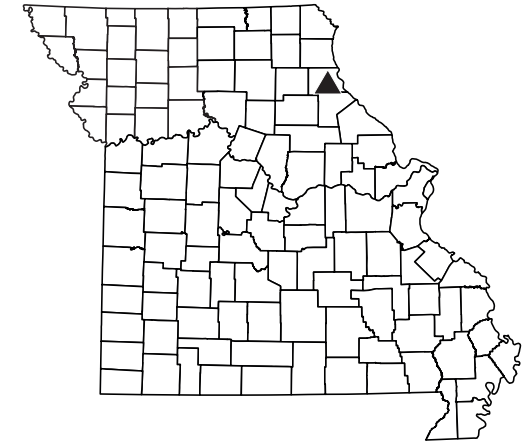
