

## Recreational Opportunities

Bird Watching – Bicycling – Fishing – Hunting

*Conservation Areas are closed from 10 p.m. to 4 a.m. except for authorized fishing, hunting, and dog training activities.*

- No littering.
- No fireworks.
- Dogs must be leashed when not used for training or hunting.
- Nuts, berries, fruits, mushrooms, and wild greens may be taken for personal consumption only. Cutting or removing other vegetation is prohibited.
- Motor vehicles are allowed on public roadways and in parking areas.
- Bicycles allowed on designated service roads year-round. Service roads can be located at <https://mdc.mo.gov/discover-nature/places>
- Horseback riding is not permitted on the area.
- No target shooting allowed.
- Swimming, scuba diving, water skiing, sailboarding, skateboarding, caving, and rappelling are not allowed.

## Fishing and Boating

*Fishing and frogging are allowed under statewide regulations with the following exceptions:*

- On lakes and ponds, fish may be taken only with pole and line and not more than three (3) poles may be used by one (1) person at any time.
- Seining or trapping live bait, including tadpoles, is prohibited.
- In Ozark streams, black bass may not be possessed from Mar. 1 through the Friday before the fourth Saturday in May.
- In lakes and ponds, daily limits are 4 catfish in the aggregate (channel, blue, and flathead); 6 black bass, 30 crappie; and all other fish, statewide limits, but not to exceed 20 in the aggregate.
- In lakes and ponds, black bass more than 12" but less than 15" must be returned to the water unharmed immediately after being caught.

## Hunting and Trapping

*Hunting is allowed under statewide regulations with the following exceptions:*

- Deer and turkey regulations are subject to annual changes. Please refer to the Spring Turkey or the Fall Deer and Turkey Hunting pamphlets for current regulations.
- Portable tree stands may be used between Sept. 1 and Jan. 31. Stands must be identified with the name

and address, or conservation number of the user. Screw-in steps or other materials that would damage the tree are prohibited.

- Decoys and portable blinds are permitted but must be removed from the area daily. Blinds may be constructed on-site, but only from willows and non-woody vegetation.
- Furbearer trapping is permitted by special-use permit.

## Driving Directions

From Buffalo take highway 32 east 11 miles to Long Lane. Turn North on Highway P for approximately 4 miles to Pelican Drive on the right.
