

Hunting and Trapping

Area is open to hunting under statewide regulations. The following special regulations also apply:

- Firearms firing single projectiles are prohibited.
- Deer and turkey regulations are subject to annual changes. Refer to Spring Turkey or Fall Deer and Turkey booklets for current regulations.
- Only portable tree stands are allowed and only from September 1 through January 31 on areas where deer hunting is allowed, by special use permit, or except as otherwise authorized. Unattended stands must be plainly labeled on a durable material with the full name and address, or Conservation Number, of the owner and be removed from the area before February 1. Use of nails, screw-in steps, and any material or method that would damage the tree is prohibited.
- Trapping of furbearers is permitted only as specifically authorized by special use permit.

Land surrounding Ferguson-Herold Conservation Area belongs to private landowners. The boundaries adjoining private property are clearly marked. 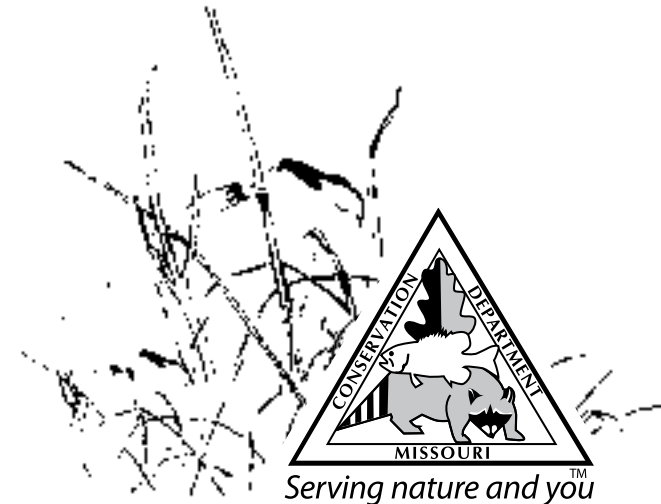
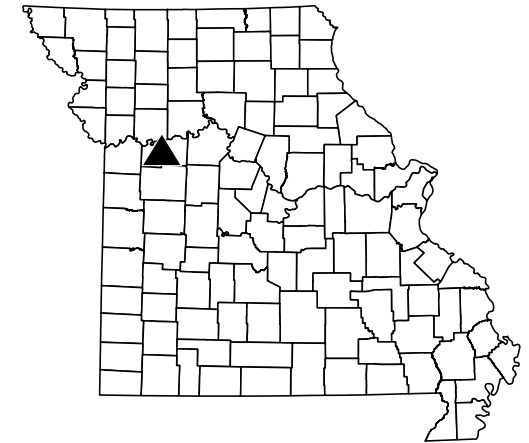

Ferguson-Herold Conservation Area

About This Area

Ferguson-Herold Conservation Area is located in western Lafayette County, 2 miles southwest of Bates City. Visitors will find a parking lot located along the Walton Road.

The Conservation Department acquired this area as a generous donation from the Harriet P. Cople Trust in remembrance of the Ferguson and Herold families, who owned and farmed the land since 1867.

Colonel James Walton and family first homesteaded the property in 1839. The Waltons sold the property to Alfred and Sedena Ferguson in 1867. The Fergusons, originally from Ohio, arrived in Pleasant Hill by train, before making their final trek with their livestock and personal possessions to the farm by wagon and on foot.

The 175-acre area includes rolling hills, crop fields, old fields, and small tracts of timber. Four small fishless ponds are present, and the head waters of the Little Horseshoe Creek start on the property.

Hunting opportunities on Ferguson-Herold Conservation Area are enhanced by the re-establishment of the historic prairie, restoration of the woodland natural communities through thinning and prescribe burning, and by the creation of early successional habitat.

Rules and Regulations

*Area hours: Open daily from 4:00 am to 10:00 pm.
Hunting, fishing, dog training are permitted at any time when authorized*

- No littering. No waste containers are provided. Area users should properly dispose of their own trash.
- No fireworks.
- No free-running pets. Dogs must be leashed or confined when not being trained or used for hunting.
- No horseback riding.
- No camping.
- Destroying, cutting or removing vegetation is prohibited. Nuts, berries, fruits, mushrooms and wild green may be taken for personal consumption only.
- Motor vehicles are restricted to parking areas.
- Bicycles allowed on designated service roads year-round. Service roads can be located at <https://mdc.mo.gov/discover-nature/places>.
- No target shooting allowed
