Application for Missouri Lifetime Permit

All required (*) fields must be completed and requested documentation provided, or the application will be returned to applicant. Please allow 10 days for your application to be processed.

Missouri Lifetime Permits are available to *Missouri residents only*. To be a Missouri resident you must have legal residence in Missouri for at least 30 days, and not hold resident privileges from another state. Lifetime permits are valid for the remainder of the recipient's life but does not include permanent residency. If the recipient moves out of state, privileges not included in the lifetime permit must be purchased as a nonresident.

Note: If born on or after January 1, 1967, a copy of your Hunter Education Certificate must be submitted with the application. (Military training and other certifications do not apply.) Lifetime hunting permits can be purchased for a child of any age, but will not be valid until he or she successfully completes the hunter education course which is available to students age 11 and older.

*STEP 2: LIFETIME PERMIT SELECTION (Mark the box indicating the lifetime permit and age of the recipient).

- **Resident Lifetime Fishing Permit** includes a Fishing Permit and a Trout Permit. (Daily trout tags are not included)
- **Resident Lifetime Small Game Hunting Permit** includes a Small Game Hunting Permit, a Migratory Bird Permit and Conservation Order Permit. (Deer, turkey and trapping permits, and a Federal Duck Stamp are not included.)
- **Resident Lifetime Conservation Partner Permit** is a combination of the Lifetime Fishing and Small Game Hunting. *Trapping not incl.*
- **Resident Lifetime Trapping Permit** includes a Trapping Permit.

***Photocopy of valid Missouri driver's license.** *A nondriver's license does not represent valid residency.* If you do not have a driver's license, please provide a copy of your Missouri voter registration card. In the case of minors (under age 18), residency of a parent is used to establish the minor's residence; therefore, a copy of a parent/legal guardian's Missouri driver's license is required.

Signature constitutes acceptance of all rules pertaining to the above permit according to the *Wildlife Code of Missouri*. Current fishing, trout, small game hunting, migratory bird, and conservation order permits cannot be refunded or applied towards the purchase of a lifetime permit.
