

2023 Agricultural Land and Deer in Missouri Survey – Results Summary

Missouri Department of Conservation

This document provides a summary of results obtained from a survey of agricultural producers in Missouri conducted in January 2023. The survey was conducted jointly by the Missouri Department of Conservation and the United States Department of Agriculture. The survey sampled 14,000 non-agri-business farm operations in Missouri that operate on at least five acres of land. Objectives of the survey were to obtain input from agricultural producers about deer populations and deer population management. This input, along with input from hunters and other stakeholders is important in assessing status of the deer population and informing harvest management decisions. Response to the survey was voluntary.

1. Which one of the following best describes your farm affiliation?

- Landowner and operator – 91.39%
- Operator but not landowner – 3.54%
- Other – 5.07%

2. Which statement best describes the deer population over the past 5 years on and around the land you own/operate?

- More deer now than 5 years ago – 36.19%
- About the same number of deer as 5 years ago – 40.14%
- Fewer deer now than 5 years ago – 13.61%
- Don't know – 10.07%

3. On the land you own/operate, do you feel there are:

- Too many deer – 27.46%
- About the right number of deer – 47.55%
- Too few deer – 12.53%
- Don't know – 12.46%

4. Generally, how do you feel about having deer on the land you own/operate?

- I enjoy having them around – 53.89%
- I enjoy deer, but their presence causes some problems at times – 32.41%
- I generally regard deer as a nuisance – 8.24%
- No opinion – 5.46%

5. On and around the land you own/operate, at what level do you think the deer population should be managed?

- Decrease population 50% (significant) – 12.46%
- Decrease population 25% (moderate) – 16.49%
- Decrease population 10% (slight) – 25.35%
- No change – 11.61%
- Increase population 10% (slight) – 21.17%
- Increase population 25% (moderate) – 9.72%

Increase population 50% (significant) – 3.20%

6. How would you describe the level of financial loss suffered by deer on the operation in 2022?

- No financial loss – 46.30%
- Slight financial loss – 26.89%
- Moderate financial loss – 13.26%
- Severe financial loss – 3.39%
- No opinion/don't know – 10.16%
