

Recreational Opportunities

Bird Watching – Bicycling – Fishing – Hiking – Hunting – Wildlife Viewing

Conservation Areas are closed from 10:00 pm to 4:00 am except for authorized camping, fishing and hunting activities.

- No littering.
- No fireworks.
- No open fires.
- No free-running pets. Dogs must be leashed or confined when not being trained or used for hunting.
- Destroying, cutting or removing vegetation is prohibited. Nuts, berries, fruits, mushrooms and wild greens may be taken for personal consumption only.
- Motor vehicles are restricted to roadways and parking areas.
- Bicycles, horses and horseback riding are permitted only on trails designated for their use and on roads and trails open to vehicular traffic, unless otherwise posted.
- Camping is allowed in designated areas. Camping is designated primitive. Stays are limited to 14 consecutive days in a 30-day period. Only two camping or sleeping units are permitted at each site on areas with established campsites. Groups of 10 campers or more must obtain a special-use permit.
- Swimming, scuba diving, water skiing, sailboarding, skateboarding, caving and rappelling are not allowed.

Fishing and Boating

Fishing is permitted under statewide regulations. The following special regulations also apply.

- On streams, fishing is permitted under statewide regulations. Other restrictions may apply to specific ponds, lakes and stream segments.
- Fish may be taken only by pole and line and not more than three poles and lines may be used by any one person.
- On impounded waters, daily limits are six black bass and four catfish in the aggregate (channel, blue and flathead) and 30 crappie. All other fish, statewide limits, but may not exceed a combined total of 20.
- All black bass less than 12 and 15 inches in total length must be returned to the water unharmed immediately after being caught.
- Bullfrogs and green frogs may be taken during the statewide season only by hand, handnet, atlatl, gig, bow, snagging, snaring, grabbing, pole and line, a twenty-two (.22) caliber or smaller rimfire rifle or

pistol, pellet gun, or crossbow, only on waters and within dates and hours those waters are open to fishing or hunting.

- Seining or trapping live bait, including tadpoles, is prohibited on all lakes and ponds.
- Salvage seining of other fish as designated in 3 CSR 10-6.550 may be permitted seasonally for personal use with a special use permit
- Boats may be used for fishing and wildlife-related activities only and may not be stored or left unattended overnight.

Hunting and Trapping

Area is open to hunting under statewide regulations, The following special regulations also apply.

- Archery and firearms deer hunting is permitted for antlered or antlerless deer on the following permits only: Archer's Hunting Permit and Firearms Any-Deer Hunting Permit. No archery antlerless or firearm antlerless permits may be used. All other statewide deer seasons and limits apply.
- Trail and game cameras are prohibited.
- Only portable tree stands are allowed and only from Sept. 1 through Jan. 31. Unattended stands must be plainly labeled on a durable material with the full name and address, or Conservation Number, of the owner and be removed from the area before Feb. 1. Use of nails, screw-in steps, and any material or method that would damage the tree is prohibited.
- Trapping of furbearers is permitted only as specifically authorized by special use permit.

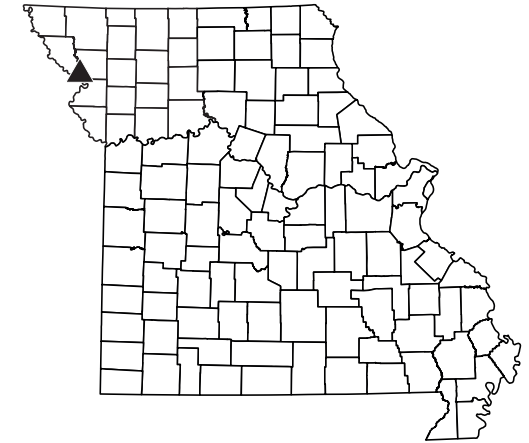
