

Area Highlights

This area includes forest, cropland and old fields. It offers access to the Meramec River. There is a boat ramp.

Recreational Opportunities

Fishing – Hunting

Conservation Areas are closed from 10 p.m. to 4 a.m. except for authorized fishing and hunting activities.

- No fireworks.
- No open fires.
- Camping is prohibited.
- Dogs must be leashed when not used for training or hunting.
- Target shooting is not allowed.
- Motor vehicles are allowed on public roadways and in parking areas.
- Nuts, berries, fruits, mushrooms and wild greens may be taken for personal use. Cutting or removing other vegetation is prohibited.
- Swimming, scuba diving, water skiing, sailboarding, skateboarding and rappelling are not allowed.

Fishing and Boating

Fishing and frogging are allowed under statewide regulations with the following exceptions:

- Seining or trapping live bait, including tadpoles, is prohibited. Gizzard shad may be taken from lakes and ponds by dip net or throw net.
- Boats may be used only for fishing and wildlife activities and may not be left unattended overnight.

Hunting and Trapping

Hunting is allowed under statewide regulations with the following exceptions:

- Deer hunting is permitted. According to the Fall Deer and Turkey Regulations: Only Muzzleloader and archery methods may be used.
- Only portable tree stands are allowed and only from September 1 through January 31. Unattended stands must be plainly labeled on a durable material with the full name and address, or Conservation Number, of the owner and be removed from the area before February 1. Use of nails, screw-in steps, and any material or method that would damage the tree is prohibited.

River 'Round Conservation Area is 330 acres in Franklin County. Take Route TT east from St. Clair. Turn left on Mill Hill, then north on Old Cove Road.

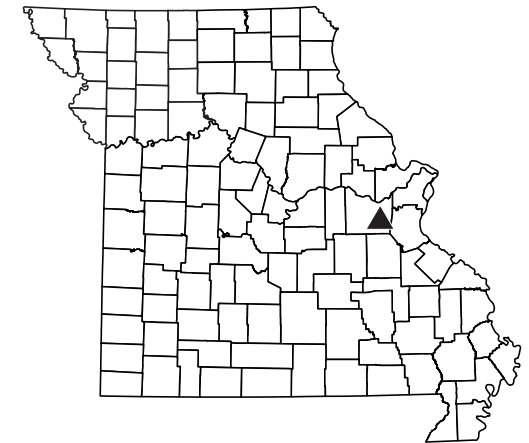
