

Sunrise Lake

About This Area

This 35-acre lake was constructed in the 1930's as a water supply for Cameron. The lake is surrounded by 63 acres of forest which provides a great setting for picnicking, nature viewing, bird watching and hiking. This lake sits adjacent to two other Cameron water supply lakes which provide additional user opportunities (see Century Lake and Eagle Lake). There is a gravel parking lot and boat ramp located on the north side off Summit Road. ADA parking is located on the south side off McElwain Drive.

Through the Recreational Trail Program, 1.3 miles of asphalted trail meeting the accessibility standards for outdoor development areas was recently added.

Sunrise Lake provides fishing opportunities for largemouth bass, bluegill, crappie, and channel catfish. Channel catfish are stocked periodically by the Conservation Department.

Rules and Regulations

Areas hours - Open daily from 4 a.m. to 10 p.m. Fishing, launching and landing boats are permitted at any time when authorized.

Fishing

| Species | Daily Limit | Length Limit |
|-------------------------|-------------|--------------|
| Black bass | 6 | 15" minimum |
| Channel catfish | 4 | None |
| Crappie | 30 | None |
| All other fish combined | 20 | None |

- Only pole and line fishing (3 per person).
- Seining or trapping live bait is prohibited.
- Bullfrogs and green frogs may be taken during the statewide season by hand, handnet, gig, long bow, and hook and line.
- Hunting and trapping is prohibited.
- No swimming.
- Horseback riding not permitted.
- Vehicles on roadways and parking areas only.
- All terrain vehicles prohibited.
- Only electric motors are permitted.

The Community Assistance Program sponsored the Missouri Conservation Department provides fisheries management and assistance to local communities for developing or upgrading facilities. In return, local communities maintain the area and facilities and open their lakes to the public. This program provides fishing and improved facilities at lakes close to home. Everyone benefits.

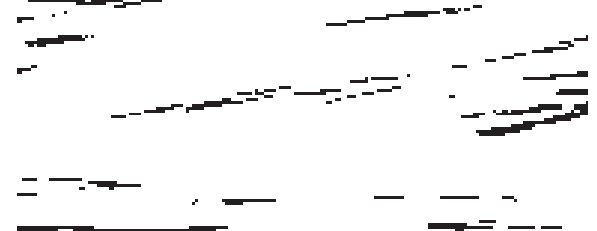
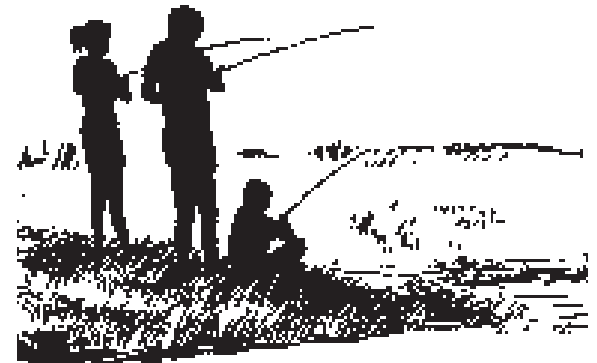
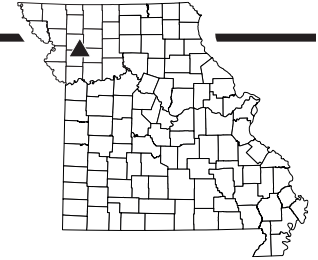
