

# Eagle Lake

## About This Area

This 96-acre lake was constructed in the 1960's as a water-supply for Cameron. An aeration system was added to Eagle Lake to prevent the lake from stratifying during the late spring and summer. This Lake is surrounded by 100 acres of forest which provide a great setting for picnicking, nature viewing, bird watching and hiking. This lake sits adjacent to two other Cameron water supply lakes which provide additional user opportunities (see Century Lake and Sunrise Lake). Since enrollment in the Community Assistance Program, the Missouri Conservation Department has added a concrete boat ramp, privy, improved the gravel road located on the lake's western shore, and expanded the parking lot.

Eagle Lake provides fishing opportunities for largemouth bass, bluegill, crappie, channel catfish, flathead catfish, and hybrid striped bass. Hybrid striped bass and channel catfish are stocked periodically by the Conservation Department.

## Rules and Regulations

Areas hours - Open daily from 4 a.m. to 10 p.m. Fishing, launching and landing boats are permitted at any time when authorized.

## Fishing

Species	Daily Limit	Length Limit
Black bass	6	15" minimum
Channel catfish and Flathead catfish	4	In the aggregate
Crappie	30	None
Hybrid Striped Bass	4	20" minimum
All other fish combined	20	None

- Only pole and line fishing (3 per person).
- Seining or trapping live bait is prohibited.
- Bullfrogs and green frogs may be taken during the statewide season by hand, handnet, gig, long-bow, and hook and line.
- Hunting and trapping is prohibited.
- No swimming.
- Horseback riding not permitted.
- Vehicles on roadways and parking areas only.
- All terrain vehicles prohibited.
- Only electric motors are permitted.

The Community Assistance Program sponsored by the Missouri Conservation Department provides fisheries management and assistance to local communities for developing or upgrading facilities. In return, local communities maintain the area and facilities and open their lakes to the public. This program provides fishing and improved facilities at lakes close to home. Everyone benefits.

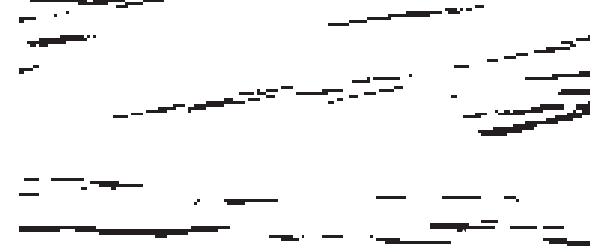
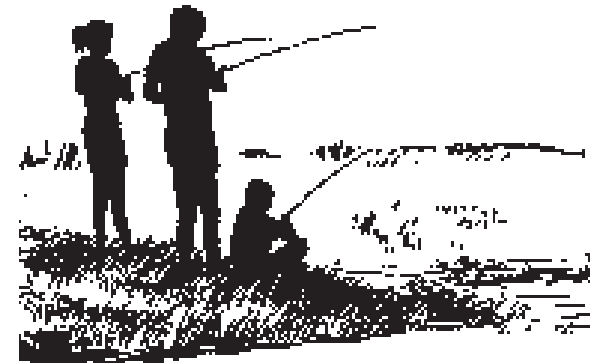
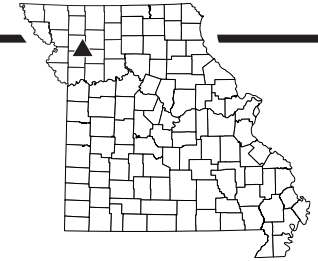
