

Recreational Opportunities

Conservation areas are closed from 10 p.m. to 4 a.m. except for authorized camping, fishing, and hunting activities.

Rules and Regulations

- No littering.
- No fireworks.
- No open fires.
- No ATV's.
- Horseback riding not permitted.
- No free-running pets. Dogs must be leashed or confined when not being used for hunting.
- Motor vehicles are restricted to graveled roadways and parking areas.
- Destroying, cutting or removing vegetation is prohibited. Nuts, berries, fruits, edible wild greens and mushrooms may be taken only for personal consumption.
- No collecting artifacts or any other activity that damages or disturbs historical or archeological features.
- No camping permitted.
- No target shooting allowed.
- Trail and game cameras are prohibited.

Hunting and Trapping

Area is open to hunting and trapping under state-wide regulations, except as further restricted by the following regulations:

- Deer and turkey regulations are subject to annual changes. Refer to Spring Turkey or Fall Deer and Turkey booklets for current regulations.
- Only portable tree stands are allowed and only from September 1 through January 31 on areas where deer hunting is allowed, by special use permit, or except as otherwise authorized. Unattended stands must be plainly labeled on a durable material with the full name and address,

or Conservation Number, of the owner and be removed from the area before February 1. Use of nails, screw-in steps, and any material or method that would damage the tree is prohibited.

- Decoys and blinds are permitted but must be removed from the area daily and may not be left unattended between the hours of 10:00 p.m. and 4:00 a.m. Blinds may not be constructed on-site from woody vegetation except for willows.
- Trapping furbearers allowed only by special use permit.

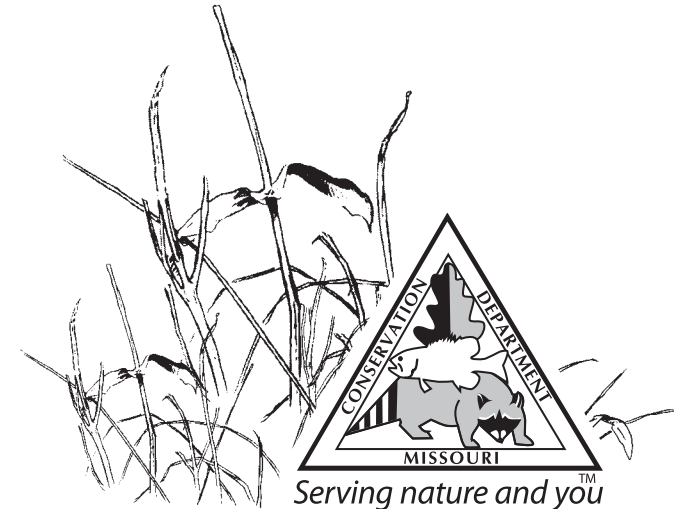
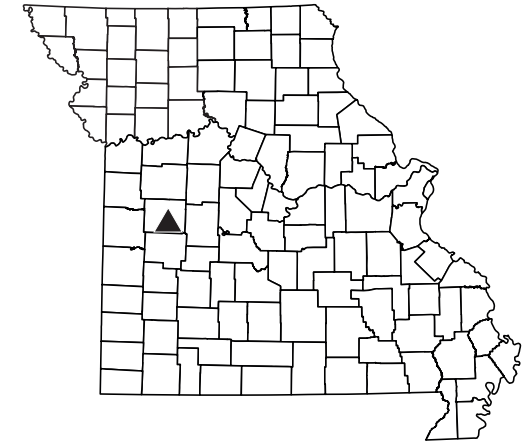
