

Area Highlights

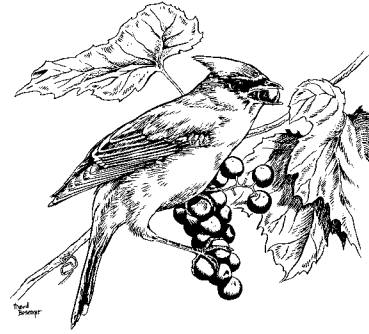
Phantom Forest Conservation Area was donated to the Missouri Department of Conservation in 1994 by Ray and Claire Moore. The 13-acre area is called Phantom Forest because Ray Moore was the illustrator of the Phantom comic. The area is leased to and maintained by the City of Des Peres Parks and Recreation, (314) 835-6150. It is located in the city of Des Peres on Barrett Station Road, between Manchester Road and Dougherty Ferry Road.

This Conservation Area is open sunrise to sunset.

- No open fires or fireworks.
- Camping is prohibited.
- Bicycling and horseback riding are prohibited.
- Motor vehicles are allowed in parking areas only.
- No target shooting is allowed.
- Dogs must be leashed at all times.
- Nuts, berries, fruits and mushrooms may be taken for personal use. Digging, cutting or removing other vegetation is prohibited.
- No capture or removal of any wildlife, including aquatic organisms in the creeks.
- No picking, collection, destruction or defacing of any natural objects.

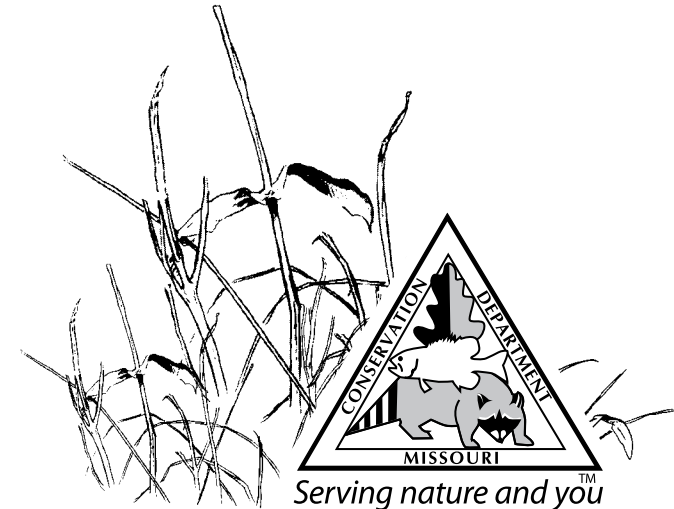
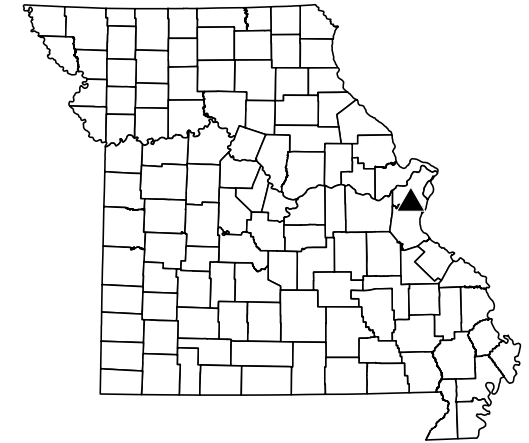
